TERMS & CONDITIONS

CANCELLATION CHARGES: In the unfortunate event a participant must cancel travel, notice to us must be via email, which must include a return receipt and read notation, or other writing stating clearly and correctly each passenger name, ship name, start and end date of cruise and a brief statement of the reason for cancellation. Other forms of notice are not sufficient. If already issued, unused air tickets must be physically returned to us before they can be cancelled. Cancellation date is the date we receive the written cancellation notice and unused tickets. A name change or substitution of participant is also treated as a cancellation in that all cancellation charges apply. Cancellation charges are per-person, based on cancellation date, as follows: For cancellations received until Aug. 31, 2011, group deposit and \$400 per person are fully refundable, from Sept. 1, 2011 to 121 days prior to departures \$200 loss of deposit. For cancellations received 120-90 days before departure: \$400 loss of deposit; 89-60 days before departure: 35% of cruise or cruise tour price; 59-30 days before departure: 50% of cruise or cruise tour price; 29-07 days before departure: 80% of cruise or cruise tour price; 6 days or less before departure: 100% of cruise or cruise tour price. Cancellation charges also apply to additional charges for upgrades, transfers and other pre-purchased services. Protection plan premiums are non-refundable. Additional cancellation fees apply for air tickets. After travel begins, there is no refund for unused services, or unused portions of cruise or cruise/tour. If after returning from the cruise you wish to inquire about about any travel service provided, please ensure that all correspondence relating to those services is received by AmaWaterways within 60 days after the cruise completion.

PASSPORT AND VISAS: A valid passport is required for each participant. Passports must be valid for at least six (6) months after scheduled return date to USA/CA. At publication time, a visa is required for a US citizen to travel to Russia, Turkey, Vietnam and Cambodia (as well as numerous other countries). For travel to Vietnam and Cambodia we require a copy of your valid passport prior to or at final payment. If not received in this time, embarkation may be denied and cancellation penalties apply. A non-US citizen must consult appropriate consulates regarding visa and other document requirements. Obtaining required visas and any other required travel documentation, and assuring these are complete and correct in all ways, is the responsibility solely of each participant. AmaWaterways is not in a position to obtain or verify accuracy or completeness of any participant visa or other required documentation and shall not be responsible or liable for delay or missed portion of any cruise or cruise tour or other problem resulting from lack of or incorrect or insufficient visa or travel documentation.

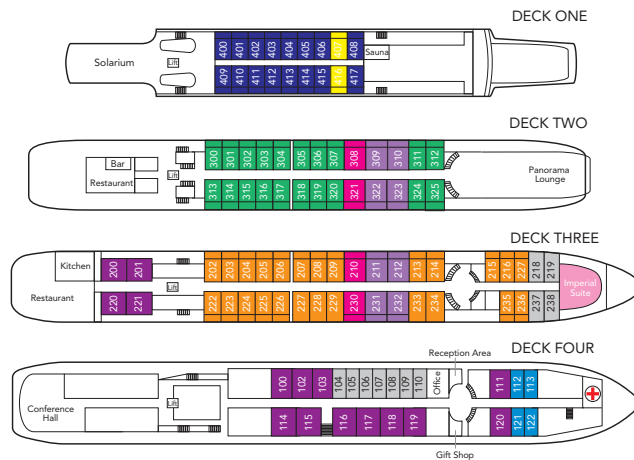
